Joseph Manning Highlights "Discovery Days"

From April 7–10, the Gabelli Presidential Scholars Program (GPSP) hosted the "Discovery Days." Students accepted to the GPSP Class of 2026 traveled from around the world to Chestnut Hill to learn more about life on campus and all that the Program has to offer.

On the first night of the weekend, prospective students and a few of their hosts ventured to the McMullen Museum of Art on Boston College's Brighton Campus to enjoy dinner, mingle with current students and faculty, and hear from guest speaker Joseph Manning (GPSP '14). Manning currently works as a Judicial Law Clerk for the New Hampshire Supreme Court, with his focus on environmental issues pertaining to climate change and renewable energy.

"I've always enjoyed the opportunity to meet prospective students and demonstrate to them the value of the [G]

PSP community," said Manning. "As an alum, my friends and professional relationships often continue to be entwined in the Presidential Scholars community. But I also strive to try and help current P-Scholars however I can."

During his undergraduate years at Boston College, Manning was an active member of EcoPledge, an organization that works to implement sustainable practices on campus, as well as the Sierra Student Coalition, which is the student-led branch of the Sierra Club, a national grassroots organization that champions environmental causes.

After an introduction from GPSP Director, Kathleen Bailey, Manning took to the podium to address students and faculty. Through personal anecdotes—varying from staying up late in Mac Dining Hall with new friends when he was a prospective student, to gaining an unexpected friend as a result of a roommate debacle during his class's trip to Nicaragua— Manning emphasized that the GPSP allows a person to build long-lasting

relationships with people with differing backgrounds and views on life.

Manning pointed out that the thread tying his speech together was the sentiment of community, but he argued that the definition usually associated with this word-similarities among people due to a single defining feature or geographical closeness-isn't an adequate way to describe the Program. Manning, in true environmentalist fashion, proposed an ecological definition. The GPSP, in his eyes, is like a collection of many unique species living and growing together.

"The [G]PSP community doesn't end when you graduate. When I was

a student, I relied on alums for guidance and advice," noted Manning, before opening up the floor to questions from the prospective students. "It was really nice to see all of the prospies together at the din-

the prospies together at the dinner at the McMullen Museum," remarked Garret McCloskey '25. "Joseph Manning gave a great speech and perfectly highlighted some of the best aspects of the Program."

Once questions concluded, students and faculty stuck around, chatting with each other and with Manning about his GPSP experience and current work in environmental law. Prospective students slowly trickled out of the Mc-Mullen Museum, ready to begin the rest of their weekend. In every respect, Joseph provided a great introduction to all of the opportunities the Program has to offer, leaving a lasting impression on those who ultimately committed.
